Dr. Nasiruddin Ahmed is a Senior Fellow of Practice at BRAC Institute of Governance and Development (BIGD), BRAC University. Prior to joining the BIGD, he was Commissioner, Anti-Corruption Commission Bangladesh. He also worked as the Secretary, Internal Resources Division, Ministry of Finance and Chairman of the National Board of Revenue. He also worked as the Secretary, Ministry of Housing and

a Japanese Center of INTERMAP study which looked into to the relationship of dietary factors with blood pressure. Later after returning to Bangladesh he started to work for generation of epidemiological data on CVD from Bangladesh. He also worked for World Health Organization, Country Office for Bangladesh as a temporary National Professional Officer and coordinated the implementation of Global Adult Tobacco Survey 2009 with the collaboration of CDC USA. His research interest lies on Cardiovascular Disease Epidemiology, Medical Statistics, NCD Prevention, Tobacco Control, Salt Consumption control etc. He is an adjunct faculty of Shiga University of Medical science, Japan. Earlier he taught public health in

University Sains Malaysia. He is leading several research projects and programs on tobacco control, hypertension, salt intake and Trans fat and also involved in designing and analysis of clinical research.
